Notes to the Financial Statements

Grey Lynn Residents Association Inc For the year ended 31 March 2022

1. Reporting Entity

Grey Lynn Residents Association Incorporated is a society established under the Incorporated Societies Act 1908.

2. Statement of Accounting Policies

Basis of Preparation

The financial statements have been specifically prepared for the purposes of meeting the requirements under the Incorporated Societies Act 1908.

Measurement Base

The accounting principles recognised as appropriate for the measurement and reporting of financial performance and financial position on a historical cost basis. The financial statements are presented in New Zealand dollars (NZ\$) and all values are rounded to the nearest NZ\$, except when otherwise indicated.

Changes in Accounting Policies

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.

Revenue Recognition

Grants requiring specified future conditions to be met are recognised as a liability upon receipt. The grants are recognised as income over the period that the specified conditions are complete and the associated costs are recognised.

Membership subscriptions are recognised at the date the subscription is received.

Income Tax

Grey Lynn Residents Association Inc is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Goods and Services Tax

The entity is not registered for GST. Therefore all amounts are stated inclusive of GST.
