Dear Resident,

Auckland Transport (AT) is implementing a residential parking zone (RPZ) in your area on the 7<sup>th</sup> of December 2018.

This will provide greater parking availability and flexibility for local residents, businesses and visitors to the area.

You are receiving this letter as your home or business is within the new Grey Lynn RPZ.

AT consulted with your community late last year on the proposal and received high numbers of feedback in response, with the majority in support of introducing the RPZ. AT subsequently changed the zone boundary based on the feedback received to help ensure the best outcome for the community.

Residents and businesses within this zone can apply for permits and coupons that give an exemption from the two hour parking restrictions. Your permits and coupons are only valid for the Grey Lynn residential parking zone.

### **Parking permits and 1-day coupons**

- The annual permit fee is \$70 per vehicle
- Each residential property in the zone is eligible to receive 50 free 1-day parking coupons per year
- Eligible residents and businesses can purchase 1-day coupons at a fee of \$5 each
- All permits and coupons are digital

### **Apply online**

We have an online service for residential parking permits. With this service you can apply for and manage your permits and coupons online.

### **Proof of residence**

Proof of residence is required for all permit and coupon applications and must be attached with your application, documents accepted as proof of residence are:

- Generated bill dated within the last two months, e.g. power or internet bill
- Electoral roll letter less than 3 months old
- Recent tenancy agreement that clearly shows your name and full address



Note: Online bank statements, water and rates bills are not accepted.

### **Timeline and processing application**

Grey Lynn residential parking zone goes live on 7<sup>th</sup> December 2018

- Processing applications may be delayed or declined if the correct information or proof of residence is not provided, we will contact you if additional information is required.
- Submitting an application for a residential parking zone permit does not exempt the vehicle from parking zone restrictions. Parking zone signs and restrictions must be adhered to until the parking permit has been approved and activated, or the vehicle may incur a parking fine.
- We will contact you to let you know if your permit(s) and/or coupon(s) application have been approved.
